Clerk's Report - 16.01.2023 Bures Hamlet Parish Council

Works completed or in hand: All grounds maintenance completed as per contract. JPB Landscapes contracted until 31st March 2024. Costs to be held until that date. Contractor trialling New Way weedspray. Sweeping in main centre of parish ongoing. Some ProW being strimmed. Leaffall and weed clearance ongoing. Lamp bollard along the Paddocks footway torn from its footings by persons unknown has been set back in place. May need to be more securely concreted at base. Goat Willow tree overhanging tree branch along the Millennium footpath removed – cost £80 + VAT. Fence damaged between the Essex Knowle and No. 1 Colchester Road. Property owner of No. 1 Colchester Road following up.

Station Hill boundary wall: This has been reported to ECC for re-pointing – Ref 2793222. Officers to make a site visit to inspect the wall.

ECC Salt Bag Scheme: Some gritting done in the parish – Station Hill and Lamarsh Hill bungalows. Stored salt bag stock sufficient for this season. Contractor to replenish grit bins and grit pavements in the parish as required.

Items reported on Highways reporting tool: Damaged sign at junction of Pebmarsh Road and Fishpits – Ref 2762026 – ECC following up. Kerb opposite New Cut reported – Ref 2770305 – ECC to monitor. Drain cover at Lamarsh Hill – Ref 2790492 – ECC to clean gully and then investigate road surface repairs. Street light No.11 The Paddocks not working – reported.

Roadbridge: SCC has installed protection barriers across the damaged railings temporarily until a works order to close the road can be put in place to do the repairs. Painting and refurbishment of the bridge structure scheduled for next summer.

Bridge Street road closure: Scheduled for February 5th and 6^{tth} to allow a new gas service pipe to be laid to an existing property. Cadent Gas confirmed its agreement is to work on the Sunday and clear the site by Monday 6am with no interference for bus services.

Waste: To review the need for a further seasonal trade waste bin in spring 2023. BDC Partnership Development Scrutiny Committee has held a Scrutiny Review into litter management across the Braintree District – Clerk has circulated her response to all members. **Ferriers Lane site:** The Clerk followed up on the last Enforcement Officer's report for the site

following an enquiry by a resident. The Chairman visited the site and agreed that there appears to be no breaches detected at present.

Bures Joint Emergency Plan: The Plan has been updated and forwarded to Braintree and Babergh District Councils.

Braintree District Rough Sleeper evidence: The Clerk had submitted a Nil return for rough sleeper evidence for Thursday 17th November.

Notification of External Auditor appointment: Details of the Parish Council's appointed auditor circulated. PKF Littlejohn LLP appointed again for a further 5 years.

Training: The training record has been updated and can be found on the parish council website. The EALC training calendar 2023 received.

BDC Supporting Communities meetings: Clerk has been attending these virtual meetings with other parish clerks and BDC Officers during the past year. Varying topics covered and the meetings allow Clerks to maintain good contact with Officers. Last meeting held 15th December and notes circulated to members.

Recycling sacks: The Clerk holds a stock of recycling sacks enabling local residents to collect a single roll of recycling sacks if they run out before the BDC annual delivery to all residents. Clerk has advertised and residents have welcomed the initiative.

Vulnerable Persons: The Clerk has signed up with Streetlink which monitors the homeless across the district. 6 Community 360 bags containing items to help protect the vulnerable from the cold have been given out at the Thursday Food Drop In session.
